

<p><b>ENGLISH</b></p> <p>As of January 10, 2023, the announcements made by U.S. Government officials and the forms referred to indicate the following will be required when applying for the new Humanitarian Parole program that President Biden announced on January 6, 2023.</p> <p>There are many things that Supporters (people in the United States) will need to start collecting and doing. There are also a few things that Beneficiaries (the person or people outside of the United States) will need to start collecting and doing as well.</p> <p>The list below is not complete because every other day or so there is new information about this program. But one thing is certain, the documents and steps listed below are necessary in order to start the process. <p><b>SUPPORTERS</b></p> <p>Now, first thing for people in the United States (the Supporters) to do for people outside of the United States (Beneficiaries):</p> <ul style="list-style-type: none"> <li>- The Supporters need to gather three years of income tax. Now, we are talking about income tax files for 2019, 2020, 2021. But If the supporters wait to file the application after February when all the 2022 income tax papers are ready, the Supporters will have to submit income tax records for 2020, 2021, 2022. I am talking about Form 1040. But if the tax preparers filed the Supporters income tax with any additional forms, we will need copies of all those forms that you sent to IRS. We will also need all W-2s of yourself and of your spouse.</li> <li>- If you have money in the bank or other types of investments, we will need the 1099 forms for all those three years of income tax.</li> <li>- We will need from each adult in your household a letter from their banks(s), signed by an officer of the bank. This letter should include the exact following information (otherwise, Immigration might deny the application, and if the Immigration rejects this application, there is no chance to start it again): <ul style="list-style-type: none"> <li>1. The date your account was opened – and if you have more than one account, the date each account was opened.</li> <li>2. The total deposits made to the account(s) for the last 12 months</li> <li>3. The current balance of the account(s)</li> </ul> </li> </ul>	<p><b>MOUN SIPÒ</b></p> <p>Kounye a, premye bagay pou moun Ozetazini (Sipòtè yo) fè pou moun ki andeyò Etazini (Benefisyè):</p> <ul style="list-style-type: none"> <li>- Sipòtè yo bezwen rasanble twazan taks sou revni. Kounye a, n ap pale de dosye taks sou revni pou ane 2019, 2020, 2021. Men, si sipòtè yo ap tann pou yo ranpli aplikasyon an apre fevriye lè tout papye taks sou revni 2022 yo pare, Sipòtè yo ap oblige soumèt dosye taks sou revni pou ane 2020, 2021, , 2022. <p>The application requires that the Sponsors provide employment verification such as:</p> <ul style="list-style-type: none"> <li>- Pay stubs for the month prior to the application AND</li> <li>- An employment letter from the Sponsor's employers. Immigration has specific guidelines about the content of the employment verification letter. This letter must state the following:</li> </ul> <ol style="list-style-type: none"> <li>1. Date hired</li> <li>2. Your position</li> <li>3. Your salary</li> <li>4. If the position is temporary or permanent</li> </ol> <p>If the employment letter doesn't provide all the required information, Immigration might deny the application.</p> <p>If you have investments, if you own stocks, bonds, mutual funds, you will need to provide proof of them.</p> <p>If you own real estate, if you own a house, you will need to:</p> <ol style="list-style-type: none"> <li>1. go to City Hall to obtain a signed and sealed copy of the title</li> <li>2. Provide mortgage statement for each mortgage you have on the house (statement must say how much is the mortgage. If you have two mortgages; you must provide a statement for each mortgage.</li> <li>3. Finally, you – the Supporter – will need an appraisal of your property. Have the house appraised. I know appraisals cost a lot, but I know a real estate agent in Norwalk, Connecticut - Guy Bocicaut – who can appraise Connecticut properties at a very affordable price. Guy Bocicaut has been providing such estimates for a long time in the area and banks, mortgage companies and attorney's accept his estimates. However, Guy Bocicaut can only serve you if your property is in Connecticut.</li> </ol> <p>The Supporters must prove their legal status:</p> <ul style="list-style-type: none"> <li>- U.S. citizens and nationals;</li> <li>- Lawful permanent residents, lawful temporary residents, and conditional permanent residents;</li> <li>- Non-immigrants in lawful status (who maintain their nonimmigrant status and have not violated any of the terms or conditions of their nonimmigrant status);</li> <li>- Asylees, refugees, and parolees;</li> <li>- Individuals granted Temporary Protected Status (TPS); or Beneficiaries of deferred action (including deferred action for childhood arrivals) or DED.</li> </ul> <p>Everyone in the household of the supporter is requested to provide all of the same documentation.</p>	<p>Aplikasyon an mande pou Sponsors yo bay verifikasyon travay tankou:</p> <ul style="list-style-type: none"> <li>- Souch peman pou mwa anvan aplikasyon an AK</li> <li>- Yon lèt travay ki soti nan patwon Sponsor a. There is a form that the supporter is required to file online. It requires a lot of information. In case of any mistake, Immigration may deny the application and they might not allow you to apply again.

On the application form, they ask many difficult questions such as:

- "When the beneficiary arrives, what are you going to do to find them a place to live, pay for their housing and food until they find work. And if they can't find work, what are you going to do to support them?"
- "If they need medical treatment and/or medication, what are you going to do to help them?"

and many more. You need to be ready to answer these questions persuasively.

This is the initial list of things the Supporter – the person based in United States – will need to start working on. We will surely need to update this list.

- "Lè benefisyè a rive, kisa w pral fè pou w jwenn yon kote pou yo viv, pou w peye kay yo ak manje jiskaske yo jwenn travay. E si yo pa ka jwenn travay, kisa w pral fè pou sipòtè yo?"
- "Si yo bezwen tretman medikal ak/oswa medikaman, kisa ou pral fè pou ede yo?"

## **BENEFICIARIES**

After that, there are several things that the people outside of the United States will need to start working on as well. Here is a partial list of these things, the things they should start to collect immediately:

- Must have a valid passport. If their current passport is expired or about to, they need to renew it.
- They also need to obtain from the office of the National Archives of Haiti copies of
  - o the birth certificate records of each person who is coming (this may include spouses and children who are not married and under 21.)
  - o Marriage certificate (if they are married)
  - o Divorce certificate (if they are divorced)
  - o Death certificate (if they are a widow or widower)

The Beneficiaries don't need to have these documents ready right now, but they should have them within a few months after the Supporters have filed the application.

## **MOUN BENEFISYE**

- Dwe gen yon paspò ki valab. Si paspò aktiyèl yo ekspire oswa sou yo, yo bezwen renouve li.
- Yo bezwen tou jwenn kopi nan biwo Achiv Nasyonal Ayiti
  - o dosye batistè chak moun k ap vini yo (sa ka gen ladann mari oswa madanm ak timoun ki pa marye ak ki poko gen 21 an.)
  - o Sètifikasi maryaj (si yo marye)
  - o Sètifikasi divòs (si yo divòse)
  - o Sètifikasi lanmò (si yo se yon vèv oswa yon vèv)

Benefisyè yo pa bezwen gen dokiman sa yo pare kounye a, men yo ta dwe genyen yo nan kèk mwa apre Sipòtè yo te ranpli aplikasyon an.
